# Notice of Nomination of the Director Candidate and Changes to the Representative Director and President

Mr. Zhu Dan, Representative Director, and President of the company, is scheduled to resign from his positions as Representative Director and Director on October 10, 2025. In addition, he has resigned from his position as President as of today. At the Board of Directors meeting held today, it was resolved to nominate the following director candidate to be submitted to the extraordinary general meeting of shareholders scheduled for October 10, 2025, and to appoint the following individual as President.

1. Changes in the Representative Director, Nomination of the Director Candidate, and Appointment of the President

#### (1) Reasons for the Change

Due to personnel adjustments within the Hisense Group (Hisense Group Holding Co., Ltd.), the parent company of the company, Mr. Zhu Dan, Representative Director and President of the company, is scheduled to resign from his position as Representative Director. Accordingly, Mr. Xu Zhan has been nominated as a candidate for Director to succeed him.

Since announcing our mid-term management plan "SHIFT 2028" on February 14, 2024, we have been working to transition from a component supplier to a "full solution system supplier." However, to respond to the rapidly changing environment of the automotive industry, we believe that further acceleration of management is necessary.

Mr. Xu Zhan has held various executive positions at Hisense (Shandong) Air Conditioning Company, Qingdao Hisense Telecommunications Company, and Hisense Refrigerator Company. Since November 2022, he has served as our Executive Vice President, driving strategic decision-making swiftly and accurately. With his extensive experience in corporate management, we believe that his knowledge and expertise will contribute to strengthening the functions of the Board of Directors.
