Announcement for the Changes in Parent Company and Affiliated Company

Sanden Corporation (hereinafter referred to as the "Company") announces that on May 31th 2021 the parent company and affiliated company changed.

1. Background of the Changes

As announced "Completion of Payment for Issuance of New Shares through Third-Party Allotment and Withdrawal of Shelf Registration" dated May 31, 2021, Hisense Japan Automotive Air-Conditioning Systems Corporation has become to the parent company. According to the subsequent investigation, it is certified that Hisense Home Appliances Group Co., Ltd. and Kelon Development Company Limited have also become to the parent companies, while Hisense Group Co., Ltd. and Qingdao Hisense Air-conditioning Company Limited have been the affiliated companies.
