# Notice of Change in Consolidated Subsidiary (by Share Transfer)

It is hereby notified that Sanden Corporation (the "Company"), at the meeting of its Board of Directors held on September 19, 2022, determined to transfer all of its consolidated subsidiary, Sanden System Engineering Corporation (hereinafter referred to as "SSE")'s share to EXEO Digital Solutions, Inc. (hereinafter referred to as "EDS"), and executed a share transfer agreement as described below.

Although this matter does not fall under the standards for timely disclosure, it is voluntarily disclosed based on the company's judgment that it is useful information. Therefore, some items and contents of disclosure items are omitted.

#### 1. Reasons for the transfer

SSE has a lot of experience in the development, operation, and maintenance of systems for municipalities and in the sale and build packaged systems, and is also expected to continue to grow steadily with the standardization of information systems for municipalities. Meanwhile, with regard to the automotive equipment business, in addition to strengthening the air conditioning domain, such as electric compressors, heat pumps, and water heating electric heaters, the company aim to become a company that provides "integrated heat management" by expanding into the area of temperature management for equipment such as batteries and motors.

The company have now made a business decision to transfer its shares of SSE to EDS, where many synergies are expected, in order to enhance SSE's growth and corporate value.
